1 Welcome and Apologies

AMB welcomed everyone to the meeting.

As this would be the last meeting that SAW would attend in her capacity as Trust Manager, the Board thanked SAW for all her hard work over the past three years and wished her a long and very happy retirement.

2 Minutes from previous meeting held on 05.03.14

MU requested that under Section 4, his appointment (Finance Director) be replaced with his name.

3 Matters arising not on Action Plan

AMB asked DB for an update regarding the work on the Articles of Association.

DB confirmed that Kier are making good progress with the AOA and will be fronting most of the cost.
